Sir,

Jeff Walburn, Charles Lawson, and Paul Brogdon being of sound mind and solid community position do prefer charges and request that the I. G. of DOE, i.e. Department of Energy Inspector General, Gregory Friedman be investigated with charges of "obstruction of Justice," and collusion in his and DOE's role in knowingly providing false information to Elected Federal Officials, the Courts, and the Scientific Community as well as the DOL, i.e. Department of Labor.

Within the last year and in progression, Gregory Friedman and the I.G. Division of DOE have offered letters to Federal Elected Officials to the effect that only one "radiation Badge" at the Piketon Gaseous Diffusion Facility was altered and was corrected as error. We accuse Gregory Friedman and the DOE Organization of knowingly covering up "criminal activity" in falsification of radiation dose, and knowingly relaying false information pertaining to "radiation and chemical dose" to the EEOICPA. DOL, i.e. Department of Labor officials have stated in print that there was a "criminal conspiracy" at Piketon Gaseous Diffusion Plant to falsify "radiation dose." These facts have not changed. The very radiation dose that the DOL is demonstrating as scientific recreation of "radiation dose" for Piketon has been purposely altered, destroyed, and falsely recreated. The outcome of this activity affects present day findings, causes workers to be misdiagnosed, not get their "due" benefits, and has frauded the Insurance Community. Further DOE has engaged in actions with their Subcontractors, Goodyear Atomic, Martin Marietta, Lockheed Martin, and The United States Enrichment Corporation, that could only be viewed as "organized criminal activity."

DOE, who is charged with the "oversight," of the Piketon Plant has acted in criminally corrupt ways to also lead the DOJ, i.e. Department of Justice away from the criminal aspects of their operation. DOE has knowingly hidden and suppressed criminal information that they possess and are now harming former workers. These acts also harm present workers. Present workers are afraid to come forward because they know DOE has allowed their Subcontractors to criminally intimidate workers who have come forward to notify officials of criminal activity.

An example used to intimidate workers was to have the "Drug Task Force" pull raids on workers homes who had come forward to file suit or to state in official documents that the Subcontractors had engaged in criminal activity. Death threats have been laid against Officials and injured workers for pursuing these facts.




We possess the documents to prove what we are saying is true. We also know of "Hostile Witnesses" that are still working at the Piketon Facility who are willing to testify.


We respectfully request an official "written response" to these allegations and expect an investigation to be performed.
